

# PADSTOW BOATYARD

## Terms and Conditions

The provision of our services are subject to the following terms and conditions:

1. A deposit of 15% or an agreed amount to be paid to Padstow Boatyard before work commences to ensure that materials and initial labour costs can be covered. In the case of new build projects an agreed payment schedule will be put in place with initial deposit and monthly payments.
2. A credit limit of £10,000 with Padstow Boatyard must be respected unless previously agreed. Once the credit limit has been reached, an invoice will be written and administered.
3. No external contractors to be used within Padstow Boatyard unless otherwise agreed. Contractors will have to provide current relevant insurance cover, agree to comply with Health and Safety at Work Act and provide evidence of their competence.
4. Any vessel using an outside contractor will be charged 10% of the contractor's total invoice amount.
5. All vessels must hold valid insurance including public liability for the duration of their stay. Only vessels being worked on by Padstow Boatyard staff are insured by the yard.
6. Vessel skipper and crew to refrain from working on vessel unless otherwise agreed.
7. All yard tools and equipment are strictly for yard staff use only and must not be used / borrowed by any skipper, crew, or contractor.
8. The winch area / shed are strictly out of bounds. The winch is only to be operated by Padstow Boatyard staff.
9. The overhead crane is strictly prohibited for public use. All lifting work with the crane will be carried out by yard staff only and charged accordingly, minimum charge is 0.5 hours.
10. Padstow Boatyard opening hours are 0800-1700 Monday-Friday, however, access can be made available on Saturdays on request. The yard will be closed for access on Sundays.

11. Padstow Boatyard cannot supply parking. Parking on the slipway is strictly prohibited.
12. Any queries regarding pricing, material costs and haulage / lay-up fees to be discussed prior to work commencing.
13. Booked slots on the cradle must be adhered to unless in emergency. Any late cancellations of booked slots will be charged at £100 per day unless agreed otherwise.
14. Padstow Boatyard reserves the right to cancel / alter any booked dates if or when deemed necessary.
15. Padstow Boatyard has a claim (known as a 'lien') over and is entitled to retain possession of any vessel being worked on, materials, and equipment, whether supplied by Padstow Boatyard or not, and no vessel, materials, or equipment can be removed from site until all payments are made in full.
16. In the case of all new build vessels, title will remain ownership of Padstow Boatyard and will not be transferred until all payments are made in full.
17. All materials ordered by Padstow boatyard will be ordered through trusted suppliers. If vessel owners wish to order their own materials, approval from Padstow Boatyard manager must be gained primarily.
18. Padstow Boatyard can assist with waste disposal; however, this will be added to the customer's invoice as per pricelist.

**Under no circumstances will any vessel leave the yard until all invoices are settled in full.**
